## ASHLAND CITY COUNCIL REGULAR MEETING

June 20, 2024

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 20th day of June, 2024 at 7:00 p.m.

Notice of meeting was advertised in the Ashland Gazette on June 14, 2024. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings hereafter shown were taken while the convened meeting was open to the public.

Mayor Anderson called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll call was taken and a quorum was declared. Anderson noted the Open Meetings Act located on the south wall of the room.

Motion by Libal, second by Lofberg to adopt the regular agenda.

Mayor Anderson opened a Public Hearing on Application #24-064 for modification of a Conditional Use located on Lot 1 Ashland RV Campground at 1301 Ash Street within the city limits of Ashland Nebraska at 7:01 p.m. Bob Luebbe, owner of Ashland RV Campground, spoke regarding the stay limit of 14 days that was placed on the original Conditional Use Permit. He requested the limit be increased to 30 days. He said there are folks that want to stay longer such as grandparents that are visiting family and visiting nurses. He noted the campground has received good reviews. He said that things have been going well and that there haven't been any problems. He said this will help generate more revenue with more campers staying on weekdays and more

sales tax revenue. He said if stays are longer than 30 days they would be taxed as long-term rentals so he wishes to keep it at a time limit of 30 days. Mayor Anderson commented that the campground is a wonderful addition to the community. With no further comment, Mayor Anderson closed the Public Hearing at 7:07 p.m.

Mayor Anderson opened two Public Hearings on Application #24-65 Ordinance 1235 for a Zoning Change to the Future Land Use Map and for a Zoning Change to the Official Zoning Map to Lots 17-18 Block 53 Miller & Clark Addition; approximate location of property is the westside of 21st Street north of Ash Street at 7:08 p.m. Mandy and Kyle Bordorsky spoke regarding the auto mechanic business they would like to open on the property. She said the business will specialize in oil changes, tire repair and maintenance on vehicles. She added the shop would have three bays and a fourth in the back for overflow vehicles. She said they feel there is a need for an additional repair shop with the growth of Ashland and to keep business in town. She said Kyle has owned a mobile mechanic business for five years. Zoning Administrator Kreici stated there will be 6-foot high privacy fence, water and sewer on site and it is in line with the comprehensive plan. He noted it abuts the Word of Hope church which is zoned B-1. He said the site was posted for the zoning change and he has not received any response from the neighbors or other people. Kyle Bordorsky said they will be removing the trees that abut the church's parking lot as part of the project. Council Member Niemeyer said the only concern he has is storage of excess vehicles that are waiting for repair or are non-licensed vehicles and that it is adequately screened. Mandy stated that they do not want it to look like a junk yard. She added they took in account the size so that there will be no cars on the street. She said that Kyle likes to keep the vehicle rotation to a couple days. Mandy said their current shop is ran out of Wahoo and they want to move it to Ashland. Kyle gave a description of their desired building. With no further comment, Mayor Anderson closed the Public Hearings at 7:17 p.m.

Mayor Anderson opened a Public Hearing on Application #24-66 for a Conditional Use Permit located on Lot 17-18 Block 53 Miller & Clark Addition; approximate location of property is the westside of 21<sup>st</sup> Street north of Ash Street at 7:18 p.m. City Attorney Fahleson stated that the testimony given at the previous public hearings applies to all three. With no further comment, Mayor Anderson closed the Public Hearing at 7:19 p.m.

Motion by Lofberg second by Crnkovich to approve the third and final reading of Ordinance 1236 – AN ORDINANCE GRANTING BLACK HILLS NEBRASKA GAS, LLC D/B/A BLACK HILLS ENERGY, A DELAWARE CORPORATION, ITS LESSEES, SUCCESSORS AND ASSIGNS, A NATURAL GAS FRANCHISE AND THE AUTHORITY TO CONSTRUCT, OPERATE, MAINTAIN, AND EXTEND A NATURAL GAS DISTRIBUTION PLANT AND SYSTEM, AND

GRANTING THE RIGHT TO USE THE STREETS, ALLEYS, AND OTHER PUBLIC PLACES WITHIN THE PRESENT OR FUTURE CORPORATE LIMITS OF THE CITY OF ASHLAND, NEBRASKA.

City Administrator Quady spoke to the Council regarding the nuisance property at 407 North 15<sup>th</sup> Street. She said Police Chief Brady witnessed the two inoperable vehicles now have engines in them and being driven. He checked the vehicles registrations and they are registered. She said the property has an extra wide curb cut and old photos show there was never any concrete between the sidewalk and the street. She added under current regulations if there is existing gravel or rock the property owner can continue to maintain it. Mayor Anderson recommended the Council keep the nuisance open until the property completely meets the City's ordinance and have the property owner contacted about what has to be done to clear up the nuisance item. He said the vehicles are parked on the lawn. Quady said the property owner has not added rock so grass is growing up through the rocks.
